On 07/10/08 at approximately 12:41 AM Officers Allen, Peace and I were on Dickson Street walking patrol in the unlit parking lot behind 313 W. Dickson. We observed a white Toyota 4Runner OKVL BJC311 parked with several occupants. Due the parking lot being unlit, thefts, and drug use in the area we approached the vehicle. I approached the passenger side rear door and observed a white male, later identified as Matthew Jones 4/22/82, sitting with his back slightly to me. In Jones lap there was a white card with white powdery

substance and in his hand was a credit card that he was using to chop up and scrape the powder.

I then opened the door and identified myself as Fayetteville Police and ordered Jones to put his hands where I could see them. Jones did not initially comply and I could not see his left hand. I then withdrew my weapon, keeping it at the low ready, and ordered Jones out of the vehicle. Jones exited the vehicle and I placed him in handcuffs. I then explained to him why he was being placed under arrest and had him sit at the rear of the vehicle. Officer Peace had the front passenger, Benjamin Cook W/M 5/8/82, exit the vehicle and placed him in handcuffs. Officer Allen had the driver, Jared Hicks W/M 06/10/83, exit the vehicle and placed him in handcuffs.

Officer Allen read all three suspects their Miranda Warnings. All three suspects stated they understood their rights. I then began a search of the vehicle. On the floorboard where Jones was sitting I located a corner of a plastic baggie with a white powdery substance inside, on the seat was the white card with the white powdery substance and credit card, and in the seat next to the white card there was a rolled up paper with another corner of a plastic baggie with white powdery substance inside. In the rear of the vehicle I located a black bag with a jar with possible Marijuana residue inside. Cook stated that the jar and bag was his. Officer Allen told me that Hicks had a straw with white powdery residue behind his ear.

I asked Jones again if he understood his rights and he stated yes. I asked him if the white powder was Cocaine and he said yes. While back at the station the white powder in the baggie on the floor field tested positive for cocaine. Several of the items were sent to the crime lab to be tested for Cocaine.

All three suspects were placed under arrest and transported to the WCSO. Jones was charged with possession of controlled substance(Cocaine), Cook was charged with possession of drug paraphernalia, and Hicks was charged with possession of drug paraphernalia.
